Rules for Authors

"Mathematical Bulletin of Shevchenko Scientific Society" publishes research articles in all areas of mathematics.

The articles submitted for publication undergo the standard peer review procedure. The journal accepts papers written in Ukrainian or English.

Since 2013, Mathematical Bulletin of the Shevchenko Scientific Society operates on the platform OJS (Open Journal System) with central server at Ya.S.Pidstryhach Institute for Applied Problems of Mechanics and Mathematics of National Academy of Sciences of Ukraine in Lviv. The submission of papers and the corresponding editorial work is realized through journal's web-site http://journals.iapmm.lviv.ua/ojs/index.php/MBSSS.

For submitting a paper and receiving news from the journal it is necessary to register at the web-site of the journal and obtain a login and password.

Requirements to papers prepared for submission in Mathematical Bulletin of Shevchenko Scientific Society

- 1. A paper should contain a short introduction, a clear formulation of the considered problem, and presentation of obtained by the author(s) new results with their complete proofs.
- 2. The volume of a paper should not exceed 20 pages.
- 3. A paper should be prepared in LATEX2ε according to the sample article ntshart.pdf, which can be found on the web-site of the journal in a zip-archive containing also the file ntshart.tex and the style file ntshart.cls, which is necessary for a proper TeX-processing the paper.

A paper should contain the following necessary elements:

- title (in English and Ukrainian);
- names of the authors (in English and Ukrainian);
- affiliations of the authors:
- e-mails of the authors;
- AMS Subject Classification, which can be found by the web-address www.ams.org/msc/;
- UDC Classification, which can be found at teacode.com/online/udc;
- keywords (in English and Ukrainian);
- abstract (in English and Ukrainian);
- the main body of the paper.
- 4. It is desirable to avoid enumerating formulas which are not referred in the text.
- 5. The list of references can be written in alphabetic order (preferable) or in order of citations in the text.

References to books, articles, and Conference Proceedings should be formatted according to the samples:

- 6. Exact coordinates of the cited papers should be checked with help of online resources like MRLookup.
- 7. The online submission of the paper consists of 5 steps. At the first step it is necessary to select a section of the journal and the main language of the paper. At this step in the field "Comments for the Editor" it is desirable to indicate the name of a Section Editor whose research interests are the nearest to the topic of the paper. At the second step it is necessary to download the PDF-file of the paper, at the third step to fill metadata (authors' names, affiliations, e-mails, the title of the paper, abstract, codes of UDC and AMS Subject Classifications, keywords in English and Ukrainian), on the fourth step one should download the LaTeX-file of the paper and on the final fifth step confirm the submission.

The input of metadata (authors' names, paper's title, annotation, keywords, UDC and AMS Classification) is a two stage operation. At the first stage it is necessary to fill the fields with names, title, abstract, AMS or UDC code by the main language of submission. At the second stage it is necessary to switch the language and fill the field with the title, abstract, UDC or AMS classification, keywords in the other language. In the OJS the names of the authors are invariant (with respect to switching the languages) identifiers of the authors and should be filled only once at the first stage.
